Boeing Delivers Trio of 777 Freighters to Qatar Airways Cargo

- Triple delivery of world's largest, most capable twin-engine freighter to power airline's air cargo business
- Delivery marks Boeing's 200th delivery of the 777 Freighter
- Additional capacity will support distribution of COVID-19 vaccines and meet global trade demand

Qatar Airways Cargo took delivery of three Boeing [NYSE:<u>BA</u>] 777 Freighters as the airline continues to build its cargo division with the world's largest and most capable twin-engine freighter. The milestone also marks the 200th 777 Freighter to be delivered.

The triple delivery comes as air freight is playing a pivotal role amid the COVID-19 pandemic – including transporting newly approved vaccines – and is projected to increase more than 4% over the next two decades.

With the arrival of the trio of 777 Freighters, Qatar Airways Cargo now operates 24 of this airplane model along with two 747-8 Freighters. As one of the leading air cargo carriers in the world, Qatar's dedicated freighter fleet serves more than 60 freighter destinations worldwide via its world-class Doha hub and also delivers freight on the belly-hold deck of passenger aircraft to an extensive network.

"With the arrival of these new freighters, we are injecting more capacity in the market which is very much required during the pandemic. The added capacity will also enable us to support the logistics around the COVID-19 vaccination, which is projected to be one of the greatest logistical challenges for the industry," said Qatar Airways Group Chief Executive, His Excellency Mr. Akbar Al Baker. "With our investments in innovation and fleet, we are able to fulfill our customers' logistical requirements and facilitate the continuity of global trade."

The 777 Freighter can fly 4,970 nautical miles (9,200 kms) and carry a payload of 224,900 pounds (102,010 kg). The airplane's long range translates into significant savings for operators like Qatar Airways Cargo as fewer stops reduce landing fees, congestion, cargo handling costs and delivery times.

"During these challenging times, Qatar Airways Cargo has been transporting humanitarian relief and medical goods to those in need, and we are proud that their growing fleet of 777 Freighters is supporting such a commendable effort," said Ihssane Mounir, senior vice president, Commercial Sales and Marketing, The Boeing Company. "We deeply appreciate our long-standing partnership with Qatar Airways and their confidence in the 777 Freighters as the backbone of their expansive global air cargo operations."

The 777 Freighter is now Boeing's top selling freighter. Customers from around the world have ordered 242 777 Freighters since the program began in 2005, including a record 45 units in 2018. Boeing, the market leader in air cargo aircraft, provides more than 90% of the dedicated freighter capacity around the world, including new production and converted freighters.

TUI AG außerordentliche Hauptversammlung

Aktionäre bestätigen Kapitalmaßnahmen und Wandlungsrecht des WSF mit großer Mehrheit / Vertrag mit WSF über Stille Einlagen unterzeichnet / Voraussetzungen für drittes Finanzierungspaket erfüllt

Auf der heutigen virtuell abgehaltenen außerordentlichen Hauptversammlung der TUI AG entsprach die Präsenz einschließlich abgegebener Stimmen 44,58 Prozent des Grundkapitals. Die Aktionäre haben den drei Tagesordnungspunkten mit großer Mehrheit zugestimmt.

Der Herabsetzung des Grundkapitals von 2,56 Euro je Aktie auf 1,00 Euro je Aktie stimmten 99,59 Prozent der Aktionäre zu, die darauf folgende Kapitalerhöhung über rund 509 Millionen Euro wurde mit 97,95 Prozent verabschiedet. Dem Wandlungsrecht des WSF gemäß der Stillen Einlage I in Aktien der TUI AG stimmten 98,04 Prozent der Aktionäre zu. Die Hauptversammlung schloss um 13:28 Uhr.

Zuvor wurden bereits die übrigen Komponenten des dritten Finanzierungspakets, das am 2. Dezember 2020 angekündigt wurde, erfüllt. Der Wirtschaftsstabilisierungsfonds (WSF) und die TUI AG haben den Vertrag über zwei stille Einlagen in Höhe von insgesamt 1,091 Milliarden Euro unterschrieben. Die Maßnahmen des WSF umfassen eine stille Einlage, die in Aktien der TUI gewandelt werden kann, in Höhe von 420 Millionen Euro (Stille Einlage I). Die zweite stille Einlage beläuft sich auf 671 Millionen Euro. Die zweite stille Einlage wurde um den Betrag der noch ausstehenden staatlichen Garantien ausgeweitet wie in der ad-hoc Meldung vom 2. Dezember 2020 angekündigt. Sobald die Garantien vorliegen, wird die zweite stille Einlage entsprechend reduziert. Die EU Kommission hat dem Vertrag bereits zugestimmt.

Durch die Umsetzung der Komponenten des dritten Finanzierungspakets wird außerdem eine Verlängerung eines Teilbetrags der bestehenden KfW-Kreditlinie in Höhe von 500 Millionen Euro gewährt. Diese wäre anderenfalls am 1. April 2021 weggefallen. Der Teilbetrag hat nun ebenfalls eine Laufzeit wie die übrige bestehende KfW-Kreditlinie (Juli 2022), sobald der ausstehende Senior Bond mit den Mitteln aus der Kapitalerhöhung abgelöst wird.

Im Rahmen des dritten Finanzierungspakets beteiligt sich die KfW darüber hinaus an einer zusätzlichen Darlehensfazilität gemeinsam mit privaten Banken in Höhe von 200 Millionen Euro.

Michael Niggemann, Vorstand Personal und Recht, Deutsche Lufthansa AG, sagt: "Ich freue mich über den weiteren substantiellen Beitrag der Cockpitbeschäftigten zur Krisenbewältigung. Wir wollen die Laufzeit des Krisentarifvertrags nutzen, um mit der Vereinigung Cockpit nachhaltige strukturelle Lösungen als Reaktion auf die veränderten Rahmenbedingungen zu vereinbaren und Kündigungen auch nach der Laufzeit vermeiden zu können "

Airbus-built CSO-2 French military Earth observation satellite launched successfully

Airbus-built CSO-2 (Composante spatiale optique) Earth observation satellites for the French Armed Forces, has been successfully launched on a Soyuz launcher from the Kourou European Spaceport in French Guyana.

CSO-2 is the second of the three-satellite CSO constellation, which will provide extremely high resolution geo information intelligence to the French Armed Forces and to its partners in the frame of the MUSIS cooperation programme (Multinational Space-based Imaging System for surveillance, reconnaissance and observation). The CSO satellites are equipped with a very agile pointing system and are controlled via a secure ground control operations centre. The constellation will offer 3D and very high resolution imaging capability, in visible and infrared bandwidths, enabling acquisition during night and day and maximize the operational use.

The CSO-2 satellite, identical to CSO-1, will however be placed on a lower polar orbit at 480 km altitude, to fulfil the identification mission of the programme.

As prime contractor for the CSO satellites programme, Airbus has provided the agile platform and avionics, and was also responsible for the integration work, testing and delivery of the satellite to CNES. Thales Alenia Space provided Airbus with the very-high resolution optical instrument.

Airbus teams will also continue leading the User Ground Segment operations, as they do currently with operating legacy programmes (Helios, Pleiades, SarLupe, Cosmo-Skymed).

Airbus was awarded the CSO contract at the end of 2010, by CNES, the French space agency acting on behalf of the Armament General Directorate (DGA). The contract included an option for a third satellite, which was activated after Germany joined the programme in 2015.

"Thanks to our close partnership since the beginning of the French Space adventure with the French MoD, now including the Space command, CNES and DGA, as well as the tremendous support across industry and partners, especially Thales Alenia Space, we did it...again! Providing the most modern and efficient observation capability for the safety of our citizens, as well as the sovereignty and independence of France and Europe, CSO is a real game changer in terms of resolution, complexity, safety of transmission, reliability and availability: only a couple of nations can claim such a capability," said Jean-Marc Nasr, Head of Airbus Space Systems.

The satellite's tremendous agility and stability enable it to quickly provide users with extremely high-quality images from the Thales Alenia Space instrument, even for the most complex acquisition schedules.

Airbus has built on the decades of experience innovations and success which led to Helios 1, Pleiades, and Helios 2, and also made use of the latest generation of gyroscopic actuators, fibre optic gyroscopes, on-board electronics and control software to optimise weight and inertia and significantly increase the pointing speed.

Rheinmetall liefert weitere Logistikfahrzeuge an die Bundeswehr – Gesamtvolumen über 500 MioEUR, darunter fast 390 MioEUR aus Konjunkturpaket

Das Bundesamt für Ausrüstung, Informationstechnik und Nutzung der Bundeswehr (BAAINBw) hat bei der Rheinmetall MAN Military Vehicles (RMMV) weitere 1.401 Militär-Lkw der Kategorie Ungeschützte Transportfahrzeuge (UTF) im Gesamtwert von 543 MioEUR brutto bestellt. 1.000 dieser Fahrzeuge sind eine Beschaffung aus Zusatzmitteln des Konjunkturpaketes der Bundesregierung. Die Fahrzeuge sollen in den Jahren 2021 und 2022 ausgeliefert werden. Der im Juli 2017 geschlossene Rahmenvertrag über die Beschaffung hochmoderner militärischer Lkw, der ursprünglich die Lieferung von 2.271 Fahrzeugen vorsah, wurde um 1.000 Stück erhöht und lässt jetzt die Beschaffung von bis zu 3.271 UTF-Lkw zu.

Aus dem ursprünglichen Rahmenvertrag werden 292 Lkw der Zuladungsklasse 5 Tonnen und 109 Lkw der Zuladungsklasse 15 Tonnen abgerufen. Diese insgesamt 401 Fahrzeuge und weitere Serviceleistungen haben einen Wert von 154 MioEUR und sollen bis Ende 2021 ausgeliefert werden. In den Jahren 2021 und 2022 sollen darüber hinaus weitere 1.000 Lkw – davon 150 Fünf-Tonner und 850 Fünfzehn-Tonner – im Wert von rund 389 MioEUR beschafft werden. Diese aus dem Konjunkturpaket finanzierten Lkw werden bis Ende 2022 ausgeliefert.

Mit dem bedeutenden Vorhaben Erneuerung der Logistikfahrzeuge leistet der Düsseldorfer Technologiekonzern für Mobilität und Sicherheit einen wesentlichen Anteil bei der Modernisierung der viele tausend Fahrzeuge umfassenden Lkw-Flotte der Bundeswehr. Der überwiegende Teil der wesentlichen Komponenten – Motoren, Achsen, Getriebe und Aufbauten – entstammt deutscher Fertigung, die Montage der Fahrzeuge wird im Wiener RMMV-Werk erfolgen.

Die hohe weltweite Verbreitung von RMMV-Fahrzeugen bringt gerade im Hinblick auf multinationale Einsätze große Vorteile bei Interoperabilität und Logistik. Aktuell gehören unter anderem Großbritannien, Australien, Neuseeland und Dänemark zum Nutzerkreis. Norwegen und Schweden haben ebenfalls Lkw-Aufträge in nennenswerten Größen bei Rheinmetall platziert.

Saudi opens airspace, borders to Qatar

Monday, a major step towards ending a diplomatic rift that has seen Riyadh lead an alliance isolating Doha.

The bombshell announcement came on the eve of the six-nation Gulf Cooperation Council (GCC) annual summit in the northwestern Saudi Arabian city of Alula, where the dispute was already set to top the agenda.

In another sign the three-and-a-half year spat was nearing resolution, the office of Qatari Emir Sheikh Tamim bin Hamad al Thani said that he would attend, after he skipped the annual meetings for the last three years.

Jared Kushner, US President Donald Trump's son-in-law and senior advisor, shuttled around the region to seek a deal and attended the signing on Tuesday of the "breakthrough", a US official said.

Kuwaiti Foreign Minister Ahmad Nasser al Sabah announced on state TV that "it was agreed to open the airspace and land and sea borders between the Kingdom of Saudi Arabia and the State of Qatar, starting from this evening."

He noted that the agreement was based on a proposal by Kuwaiti emir Sheikh Nawaf al Ahmad al Sabah, reflecting the nation's repeated efforts to mediate in the crisis.

Global praise for reopening of Qatar-Saudi borders

The US Department of State welcomed the decision to open the airspace and the land and sea borders between the Kingdom of Saudi Arabia and the State of Qatar.

"A resolution of the wider three-year dispute between the Quartet and Qatar is in the interest of all Gulf Cooperation Council GCC members as well as the interest of the United States," said a State Department spokesperson in a statement to Al Hurra TV channel.

Kuwaiti Foreign Minister Sheikh Ahmad Nasser Al Mohammad Al Sabah announced on Monday that an agreement had been reached according to which the airspace and land and sea borders would be opened between the Kingdom of Saudi Arabia and the State of Qatar, starting from Monday night.

Turkey also welcomed the decision to open the airspace and land and sea borders between the State of Qatar and the Kingdom of Saudi Arabia.

"We welcome the agreement made to open land, sea and air borders between Qatar and Saudi Arabia as of tonight," the Turkish Foreign Ministry said in a statement, noting that this development is an important step towards resolving the Gulf crisis that has been going on since June 2017.

The Ministry praised the efforts of the international actors who contributed to reaching the agreement through their mediation efforts, led by the State of Kuwait.

The Ministry expressed the hope for a comprehensive and permanent resolution of the Gulf rift on the basis of mutual respect for the sovereignty of the countries, stressing that Turkey, which is a strategic partner of the Gulf Cooperation Council and places great importance on the security and stability of the Gulf region, will continue to support all efforts in this direction.

The Hashemite Kingdom of Jordan welcomed yesterday the outcome of the 41st session of the Supreme Council of the Cooperation Council for the Arab States of the Gulf (GCC), hosted by the Kingdom of Saudi Arabia. In a statement reported by Petra, Jordan's Deputy Premier and Minister of Foreign Affairs and Expatriates Ayman Safadi said that the final communique by the Gulf Arab leaders is a major achievement to heal the rift, end the Gulf crisis and restore the brotherly relations to their normal course, which will bolster solidarity and stability in the Arab Gulf region, serve its people's aspirations for development and prosperity and strengthen pan-Arab solidarity and efforts to face common challenges.

Safadi hailed the keenness of all the brothers to enhance Gulf and Arab solidarity and stability, which was manifest in the agreement to end the dispute and bring reconciliation.

The minister valued the efforts of the late Kuwaiti Amir Sheikh Sabah Al Ahmad Al Jaber Al Sabah, which were pursued by H H Amir Sheikh Nawaf Al Ahmad Al Jaber Al Sabah, as well as the efforts of the United States and all the parties to end the crisis.

Safadi said Jordan will continue to work with all the brothers to promote solidarity and joint Arab action to face challenges and deepen Arab cooperation in the service of joint Arab interests and to achieve a better future for all Arab countries.

Secretary-General of the Arab League Ahmed Aboul Gheit has also welcomed the outcome of the Gulf Cooperation Council (GCC) summit, which was held yesterday in Al Ula governorate in the Kingdom of Saudi Arabia.

In a statement following his participation in the GCC summit, Aboul Gheit, affirmed that "any effective measure that leads to calm and normalcy among Arab countries will be in the interest of the collective Arab unity, and it for sure it is welcome, and in turns would strengthens the power and influence of the Arab League."

"There is no doubt that the huge challenges facing the Arab world call for healing the rift as soon as possible and achieving consensus between Arab brothers, as any Arab differences should be solved for the sake of Arab security, which we all need as soon as possible," he added. Aboul Gheit stressed on working to reinforce a positive situation that emerged from the "Al Ula summit" and build on it to enhance confidence, appreciating efforts exerted by involved Arab countries to end the Arab rift, at a difficult time where Arabs are facing huge challenges.

The Islamic Republic of Pakistan also welcomed the decision to reopen the airspace and land and sea borders between the State of Qatar and the Kingdom of Saudi Arabia. In a statement posted on its website yesterday, the Pakistani Ministry of Foreign Affairs appreciated other steps being taken by the countries of the Gulf Cooperation Council (GCC), which will contribute to resolution of outstanding issues between the GCC countries.
